OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE FOLLOWING SWEEPSTAKES IS OPEN TO LEGAL RESIDENTS OF THE STATE OF TEXAS ONLY, WHO MEET THE ELIGIBILITY REQUIREMENTS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED. IN THE EVENT THERE IS NO GRAND PRIZE WINNING DICE ROLL, THEN THE GRAND PRIZE WILL NOT BE AWARDED.

NO SALES PRESENTATION IS REQUIRED TO ENTER.

Sweepstakes is governed by these official rules ("Official Rules"). By participating, entrant agrees to the Official Rules.

Sweepstakes Name: Lennar and Village Builders Win Big Live Big Sweepstakes (the "Sweepstakes").

Promotion Period: Sweepstakes begins on **September 28, 2009** and ends on **October 24, 2009**. Registration deadlines for each of the methods of entry are set forth below. The grand prize contest event will occur on Saturday, **October 24, 2009** between approximately **1:00 pm CT and 4:00 pm CT** at the Houston Premium Outlets, 29300 Hempstead Road, Cypress, TX 77433 ("Grand Prize Event"). The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

Who May Enter: Sweepstakes is open to legal residents of the State of Texas only, who are age 21 or older as of date of entry with a valid driver's license, except the following classes of persons who are not eligible to enter:

- a. Employees, officers, and directors of Lennar Homes of Texas Land and Construction, Ltd., Lennar Homes of Texas Land and Construction, Ltd. d/b/a Village Builders, Houston Premium Outlets (collectively "Sponsors"), Zimmerman Advertising, Swirl Integrated Media, Million Dollar Media, LLC ("Sweepstakes Administrator"), any partnering radio or television stations, other radio stations or television stations in the greater Houston metropolitan area, each of their respective franchisees, affiliated companies, subsidiaries, distributors, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this Sweepstakes (collectively, "Released Parties") and the members of the immediate families or households of any of the above, whether or not related. "Immediate family members" includes, for purposes of this Sweepstakes, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grand children (including step grand children) and each of their respective spouses.
- b. Individuals who are unable or unwilling to be present to participate in the Grand Prize Event on **October 24, 2009**. All travel costs and expenses associated with attending the Grand Prize Event are at each potential Finalist's sole expense.

Fully complete the official entry form with all required information including your complete name, complete address (including city, state and zip), valid email address, birth date, and phone number(s) (including area code(s)). Deposit the completed entry form in the specially designated entry box at participating Lennar and Village Builders' communities. Entries **cannot** be submitted online, at Firehouse Subs locations or at the Land Rover Houston North location. A list of participating Lennar and Village Builders' communities and Firehouse Subs locations is provided at the end of these Official Rules. **LIMIT ONE ENTRY PER HOUSEHOLD PER VISIT TO PARTICIPATING LENNAR OR VILLAGE BUILDERS' COMMUNITY. All entries submitted at participating Lennar and Village Builders' communities must be submitted by close of business on 10/21/09 to be eligible.**
2. **On Air Contest Qualification:** Listen to the following stations during the dates and time listed below for the announcement of the cue to call:
 - KLOL-FM. Each day on October 12, 2009 and again on October 13, 2009 between the hours of 6:00 am and 10:00 am Central Time ("CT"). Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the Station contest line at 713-212-6342 will qualify as a finalist for the Grand Prize Event, upon confirmation of eligibility.
 - KILT - AM. Each day on October 5, 2009 and again on October 16, 2009 between the hours of 6:00 am and 10:00 am CT. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the Station contest line at 713-390-5610 will qualify as a finalist for the Grand Prize Event, upon confirmation of eligibility.
 - KHMx-FM. Between October 5, 2009 and October 9, 2009 between the hours of 6:00 am and 9:00 am Central Time ("CT"). Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the Station contest line at 713-212-5965 will qualify as a finalist for the Grand Prize Event, upon confirmation of eligibility.
 - KILT-FM. Each day on October 12, 2009 and again on October 19, 2009 between the hours of 3:00 pm and 9:00 pm Central Time ("CT"). Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the Station contest line at 713-390-5458 will qualify as a finalist for the Grand Prize Event, upon confirmation of eligibility.
 - KKHH-FM. Each day on October 2, 2009 and again on October 3, 2009 between the hours of 11:00 am and 3:00 pm Central Time ("CT"). Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the Station contest line at 713-390-5957 will qualify as a finalist for the Grand Prize Event, upon confirmation of eligibility.

At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be selected as a finalist only once. There will be up to a total of ten (10) finalists selected from all five stations during the specified dates. The stations are not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the online streaming of the stations' broadcast signals, listeners to the online streams of the stations may not be able to participate in or may be disadvantaged in participating in on-air contests.

3. **Great Day Houston:** On each of **10/1/09** and **10/21/09**, Great Day Houston shall conduct a random drawing from among all eligible audience members who are present for each show date to select five (5) Finalists to participate in the Grand Prize Event Contest, subject to verification of eligibility. Audience member must sign name on paper form to be entered into the drawing.
4. **Complete an Entry Form at the Houston Premium Outlet VIP Event on 10/24/09:** Visit the Houston Premium Outlet VIP Event located at 29300 Hempstead Road, Cypress, TX 77433 between 10:00am CT and 11:55 am CT on 10/24/09 to obtain an official entry form (visit the customer service desk for event times and location). Official entry forms will be made available (while supplies last) prior to the Finalist drawing at 1:00 pm CT. Official entry forms' availability may be limited. Obtain and fully complete an official entry form with all required information including your name, address (*including city, state and zip code*), email address, birth date, daytime and evening phone numbers (*including area code(s)*), and deposit completed entry in the registration box specially designated for entry at the Houston Premium Outlet VIP Event by 12:00pm CT. **Maximum of one entry per person for Houston Premium Outlet VIP event.**
5. **Last Chance Registration at the Grand Prize Event on 10/24/09:** Visit the Grand Prize Event on **October 24, 2009** between approximately 12:00 pm CT and 1:50 pm CT. Official entry forms will be made available (while supplies last) prior to the start of the grand prize dice roll contest. Official entry form availability may be limited. Obtain and fully complete an official entry form with all required information including your name, address (*including city, state and zip code*), email address, birth date, daytime and evening phone numbers (*including area code(s)*), and deposit completed entry in the registration box specially designated for entry at the Grand Prize Event by 1:50 pm CT. **Maximum of one entry per person for 'Last Chance' registration.**

Information on all entries must be hand-printed. No mailed, emailed, telephoned, faxed, or mechanically reproduced entries will be accepted. Receipt of entries will not be acknowledged nor will proof of submission of an entry form be deemed proof of receipt.

Released Parties are not responsible for lost, late, misdirected, illegible, incomplete, invalid, unintelligible, damaged, or mutilated entries or for lost or stolen entry boxes, or for entries submitted in a manner that is not expressly allowed under these Official Rules, or for any difficulty in the downloading or printing of an on-line entry form, or for any entry not submitted or received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer or cellular transmissions and/or network connections; all of which will be disqualified.

Each participant may only submit an entry on behalf of his/her own household. Any entry submitted on behalf of another individual or household, or using another person's email address or name will be disqualified and ineligible to claim any prize. Sponsor has no obligation to advise an entrant of an incomplete or otherwise non-compliant entry. Use of any automated system to participate is prohibited and will result in disqualification and all such entries will be deemed void. All entries received become the property of the Sponsor and will not be returned.

Finalist Selection & Notification: A maximum total of (100) finalists ("Finalists") will be selected to participate in the Grand Prize Event as follows:

- **(74) Finalists selected from entries received at participating Lennar and Village Builders Welcome Home Centers:** A random drawing will be held on or about **October 22, 2009** from among all eligible entries received at participating Lennar or Village Builders Welcome Home Centers to randomly select a total of seventy-four (74) Finalists.
- **(10) Finalists selected from on-air contests:** Ten (10) Finalists will be selected on-air on the participating radio stations as described in Paragraph 2 of the How to Enter section of these Official Rules.
- **(10) Finalists selected from Great Day Houston Audience Members:** A total of ten (10) Finalists (5 per show date) will be randomly selected from among eligible audience members during the designated Great Day Houston show broadcasts;
- **(1) Finalist selected from entries received at the Houston Premium Outlets VIP Event:** A total of one (1) Finalist will be randomly selected at 12:00 pm CT at the Houston Premium Outlet VIP Event from among all eligible entries received in the specially designated Houston Premium Outlet VIP Event entry box, subject to verification of eligibility. The selected potential Finalist's name will be announced by Sponsor or Sweepstakes Administrator at the Houston Premium Outlet VIP Event, and the potential Finalist must be present at the time of his/her selection and announcement in order to be eligible to participate in the Grand Prize Contest (see below). The Sponsor or Sweepstakes Administrator will announce the name of the selected potential Finalist **two times over an approximate 1-minute period.** The selected potential Finalist must immediately confirm his/her presence and intent to participate in the Grand Prize Event Contest. If the selected potential Finalist fails to make his/her presence known at the time of his/her name announcement, s/he will be disqualified. An alternate potential Finalist may be selected from all remaining eligible entries received in the specially designated Houston Premium Outlet VIP Event entry box during the Houston Premium Outlet VIP Event and notified per the procedures outlined above.
- **(5) 'Last Chance' Finalists:** A random drawing shall be held at approximately 2:00 pm CT on **October 24, 2009** to randomly select five (5) 'Last Chance' Finalists from among all eligible entries received in the registration box specially designated for entry at the Grand Prize Event, subject to verification of eligibility. Each selected potential Finalist's name will be announced by Sponsor or Sweepstakes Administrator at the Grand Prize Event, and the selected potential Finalists must be present at the time of their selection and announcement in order to be eligible to participate in the Grand Prize Contest. The Sponsor or Sweepstakes Administrator will announce the name of each selected potential Finalist **two times over an approximate 1-minute period.** Each selected potential Finalist must immediately confirm his/her presence and intent to participate in the Grand Prize Event Contest. If a selected potential Finalist fails to make his/her presence known at the time of his/her name announcement, s/he will be disqualified. Alternate potential Finalists may then be selected from all remaining eligible entries received in the registration box specially designated for entry at the Grand Prize Event and notified per the procedures outlined above.

Maximum of one Finalist per household, regardless of entry method. Potential 'Last Chance' Finalists, the potential Finalist selected at the Houston Premium Outlet VIP Event, potential Finalists selected during on-air contests and potential Finalists selected during Great Day Houston broadcasts will be notified as provided above. All other potential Finalists will be notified initially by phone, email and/or in person of their selection. Except for potential 'Last Chance' Finalists and the potential Finalist selected at the Houston Premium Outlet VIP Event, who must confirm participation in the Grand Prize Event Contest as provided above, **each potential Finalist must confirm receipt of his/her notification, eligibility and intent to participate in the Grand Prize Event within twenty-four (24) hours of notification/selection, or he or she may be disqualified.** Any potential Finalist that cannot be reached or contacted to confirm his/her selection within twenty-four (24) hours after an initial notification may be disqualified and in Sponsor's sole discretion, an alternate Finalist may be selected and notified, time permitting.

Any potential Finalist (regardless of selection method) who does not meet the eligibility requirements, does not wish to participate in the Grand Prize Event, does not confirm his/her receipt of selection notification and ability to attend and participate in the Grand Prize Event within twenty-four (24) hours of notification (except for 'Last Chance' Finalists and the Finalist selected at the Houston Premium Outlet VIP Event), or who is unable or unwilling to attend the Grand Prize Event will be disqualified. At Sponsor's sole discretion, an alternate Finalist may then be randomly selected from all remaining eligible entries received, and notified per the procedures outlined above, time permitting. Only Finalists selected and notified by Sponsor, who have confirmed receipt and acceptance of their Finalist selection, will be eligible to participate in the Grand Prize Event. All other entrants are ineligible. **Finalist selection and participation is non-transferable.** No other individual, proxy or "stand-in" may participate on behalf of a potential Finalist.

Decisions of Sponsor and Sweepstakes Administrator in the selection of potential Finalists and all matters related to this Sweepstakes are final. **The total number of Finalists to be selected for the Sweepstakes is a total of (100) eligible Finalists. However, a lesser number of Finalists may be selected if an insufficient number of eligible entries is received or if Sponsor is unable to verify all selected potential Finalists prior to the Grand Prize Event.**

Grand Prize Event: The Grand Prize Event shall occur on October 24, 2009 between 1:00 pm CT and 4:00 pm CT at Houston Premium Outlets, 29300 Hempstead Road, Cypress, TX 77433. Finalists must be present at the date, time and location as specified to participate in the Grand Prize Event (any pre-selected finalists must be checked-in between 1:00 pm – 2:00 pm CT. Any pre-selected finalist who is not checked-in by 2:00p CT may be disqualified). Any Finalist who fails to appear by the required deadline will be disqualified and will not receive any alternate contest attempts, prize substitution or compensation. Sponsor reserves the right in its sole discretion to change the date, time or location of the Grand Prize Event. Finalists will be notified of any changes at the time of their selection and/or notification. **Difficulties with getting to the Grand Prize Event to participate in the Grand Prize Event Contest are not the responsibility of Sponsor. Each Finalist is solely responsible for any travel costs or expenses associated with attending the Grand Prize Event.**

Grand Prize Event Contest: In order for the Grand Prize to be awarded to an eligible Finalist, the Finalist and their dice roll attempt must comply with all the requirements set forth in these Official Rules. Each Finalist must print and sign his/her full name on the first unoccupied line of the provided official Finalist registration form prior to his/her dice roll attempt. **Each Finalist will receive a maximum of one (1) dice roll attempt.** Each eligible Finalist must roll all six (6) dice provided by Sponsor or Sweepstakes Administrator during his/her dice roll attempt. Finalists may roll the dice with their hands or in a dice roll cup provided by Sponsor or Sweepstakes Administrator. In order for the Grand Prize to be awarded, each die must come to rest with the predetermined winning side face up on a single roll attempt by a Finalist. The winning symbols are: **W-I-N-B-I-G.**

Eligible dice roll attempt requirements include:

- All dice roll attempts must occur in the presence of the Sweepstakes Administrator, and must be recorded on video tape in its entirety. Any dice roll attempt not in the presence of the Sweepstakes Administrator, or that is not video taped for any reason will be disqualified and is not eligible for the Grand Prize;
- Finalists will not be permitted to take any practice or warm-up tosses prior to their attempt. Once a die has been rolled, their attempt is considered to be started.
- **Each eligible Finalist must roll all six (6) dice all at one time.**
- Finalists may not attempt to change the outcome of any rolled die by hitting the die with a subsequent roll attempt. Neither the dice roll surface nor the dice may be altered, modified or otherwise interfered with in order to enhance a Finalist's chances of winning.
- All six (6) dice must be rolled on each individual contest attempt. The winning outcome must occur during a single roll attempt – i.e. Finalists may not combine letters on multiple rolls. Each roll is its own unique contest attempt, and the six (6) winning letters must all land face-up on a single roll.
- Each die must be tossed in a completely random manner that does not allow the Finalist to "set" or "slide" the dice, alter or influence the random outcome of the roll.
- Each die must be rolled a minimum of 2-feet in distance from the Finalist, in order to prevent the Finalist from altering, affecting, influencing, or enhancing the random outcome of any roll. The Sweepstakes Administrator will designate the demarcation line that each die must cross during the roll.
- All dice must come to rest lying flat on the designated dice roll surface.
- All dice must land on and remain on the designated dice rolling surface.
- No rolled die may come in contact with any person or object other than the designated rolling surfaces or walls.
- If any die comes in contact with another person or object (other than the dice roll surface or designated walls or backstop) for any reason; or if any person or object in any way interferes, alters, changes, influences or affects the random outcome of the roll, then the entire attempt is disqualified and the Finalist may not receive another attempt.

The following will result in the Finalist being required to re-roll his/her entire dice roll attempt:

If any of the following outcomes occur, that dice roll attempt is disqualified and the Finalist will be granted one (1) re-roll attempt (the Finalist must re-roll all six (6) dice):

- If the Sweepstakes Administrator deems that any die has failed to cross the dice roll demarcation line.
- If any die is leaning in any manner.
- If any die leaves the designated dice roll playing surface.
- If any Finalist inadvertently drops a die as he/she is preparing to roll, and the dropped die does not meet the eligible dice roll requirements as stated in these Official Rules.

Under the above circumstances, an eligible Finalist may have one (1) re-roll attempt. If the second dice roll is ineligible, the entire second dice roll attempt will be disqualified and the Finalist will not be eligible to claim any prize, regardless of the outcome of the ineligible roll.

Prize Awards & Delivery:

Grand Prize: In the event of a successful dice roll attempt, if any, the eligible Finalist who successfully completed the contest will be awarded the Grand Prize subject to approval and verification of compliance with these Official Rules. The Grand Prize is:

- **A new Lennar home (which may be chosen from among the available inventory homes identified by Lennar in participating communities or new construction, as determined by Lennar in its sole discretion) in the Houston, TX Division area with a maximum listing price not to exceed \$300,000. Approximate retail value of the prize depends on the value of the home model selected by the potential winner up to a maximum of \$300,000.**
- **\$60,000 to be used at a designated auto dealership selected by Lennar**
- **\$60,000 to be used at a designated furniture dealer selected by Lennar**
- **A \$10,000 gift card to be used toward a shopping spree at the Houston Premium Outlets, 29300 Hempstead Road, Cypress, TX 77433**
- **\$70,000 cash, awarded in the form of a check to a winning Finalist (if any)**

Total maximum value of Grand Prize award: \$500,000. Potential winner (if any) may elect to receive an equivalent cash value in lieu of a credit at one or all of the selected vendors and the gift card. **Potential winner may not elect to receive cash in lieu of the new Lennar home.**

Sponsor shall designate in its sole discretion available new construction or inventory homes and communities for the potential Grand Prize winner's prize selection. Potential Grand Prize winner must accept one of the Sponsor designated homes that are currently available and remain unsold in Sponsor's inventory or as built per contract. Grand Prize winner may not substitute, exchange, or apply the value towards a higher cost or alternate home or property, except in Sponsor's sole discretion. If the home to be awarded is new construction, construction may not begin on the home without a written contract and finalized selections. Sponsor shall not be responsible for any delay in construction for a new construction home.

Sponsor reserves the right in its sole discretion to allow winner, if any, to accept a home with a lower listing price if available. If the actual home selected and awarded to the grand prize winner is under the maximum \$300,000 listing price, the winner will not be awarded the difference between the homes actual listing price and the \$300,000 maximum prize value.

Sponsor reserves the right in its sole discretion to allow winner, if any, to request a home with a greater listing price based upon availability. If the actual home selected and awarded to the grand prize winner is over the maximum \$300,000 listing price, the winner will be required to pay the different between the homes actual listing price and the \$300,000 maximum prize value at the time of closing.

The new Lennar home element of the Grand Prize includes only the listing price of the home up to a maximum of \$300,000. The Grand Prize does not include any other expenses or fees. **This is not a public offering.** Winner may be required to become a member of the designated developments homeowners association and must abide by all regulations and requirements of the association, subject to the terms and conditions of any applicable Public Offering Statement.

The conveyance of any home selected by the Grand Prize winner by Lennar will be subject to all covenants, easements, rights-of-way and restrictions of record pertaining to the property, as well as applicable ad-valorem taxes. The home will be awarded "as is" with no furniture, upgrades or additional options included.

All taxes required to be paid upon acceptance of the prize and any expenses not specifically mentioned as part of the prize shall be the sole responsibility of the winner, including without limitation, income taxes, real estate transfer taxes, deed recording changes and closing costs. All additional fees and expenses, including, but not limited to, maintenance and repair fees, utilities, services, costs of furnishing, homeowners association fees, homeowners insurance and any other property insurance, property tax, and real estate taxes incurred in connection with acceptance and use of the Grand Prize are the sole responsibility of the winner. Grand Prize winner agrees to sign any additional release and/or prize claim forms that Sponsor may require.

A maximum of (1) Grand Prize will be awarded to the first Finalist who successfully completes the Grand Prize winning contest requirements. The Grand Prize Event Contest is immediately concluded following the first successful dice roll attempt, regardless of the number of Finalists remaining – and no additional Finalists will be allowed to attempt the Grand Prize Event Contest following the first successful roll. **In the event there is no Grand Prize winning dice roll, then the Grand Prize will not be awarded.**

Winner(s) must accept delivery of prizes from Sponsor as instructed by Sponsor. All other costs related to prize delivery and acceptance are the responsibility of prize winners, including but not limited to federal, state and local taxes. All properly claimed prizes will be awarded. Prizes are non-transferable and no cash redemption or prize substitution allowed, except in Sponsor's sole discretion or as provided herein. Sponsor reserves the right to substitute a prize of equal or greater value if an advertised prize becomes unavailable.

Winners will be required to complete and return a W-9 form (*if prize value exceeds \$600.00*), affidavit of eligibility, and liability/publicity release, and present a valid driver's license before a prize will be awarded. Winners of prizes valued at more than \$600.00 will be issued a 1099 form reflecting the value of the prize(s) and are responsible for paying all income taxes on prize(s). Failure to collect or properly claim any prize in accordance with these Official Rules will result in forfeiture of the prize. If forfeited for any reason, Finalist will not receive any other prize substitution or compensation. **Total ARV of all prizes available: \$500,000.**

Additional Rules & Restrictions: By participating in this Sweepstakes, entrants agree to abide by and be bound by the Official Rules and the decisions of the Sponsor and Sweepstakes Administrator, which shall be final in all matters relating to this Sweepstakes. In the event an entrant wins the prize and is later found to be in violation of these Official Rules, he/she will be required to forfeit the prize or to reimburse Sponsor or Sweepstakes Administrator for the stated value of the prize, if such violation is discovered after winner has used the prize. Participation in Sweepstakes constitutes permission for the Sponsor and its designees to use entrants' names, cities and states of residence and/or likenesses for purposes of advertising and trade in any and all media now or hereafter known worldwide

on perpetuity without limitation or further compensation, notification or permission, unless prohibited by law. False, fraudulent or deceptive entries or acts shall render entrants ineligible to receive a prize.

By participating, entrants agree to hold all Released Parties harmless from any claims, losses, actions, or damages of any kind, whether actual, incidental or consequential, for injury (including but not limited to death), damages, losses or expenses arising out of or relating to entrant's participation in this Sweepstakes, or the acceptance, possession or use/misuse of a prize, and to assume all liability thereof.
